Mr Parker commented on the amount of interest earned on the Treasury Deposit Account in just a six month period. The Clerk will renew the Account for another six months and deposit £900,000.00.

11. AOB.

a. Mrs Oakley reported that a grant of £3000.00 was awarded to Horspath Parochial Charity around three years ago to register the Poor's Land. The land has now been registered at a cost of £896.00. HSPC has now been made aware that the grant was also used to insure the Poor's land for the last 3 years at a cost of £898.46. The remainder of the grant has been paid back to HSPC. Mrs Oakley stated that someone has previously expressed an interest in this land to use for farming, but no further action has been taken. Trustees agreed that HSPC do not award grants to pay for insurance and asked the Clerk to write to the Trustee of the Parochial Charity stating that HSPC will not award any further grants to cover insurance. Mr Burgess stated that in past years it has been mentioned about the Poor's Land merging with HSPC, but as the Trustee of the Parochial Charity is no longer involved with HPC/HSPC, no further action has been taken.

12. APPLICATIONS FOR FUNDING.

7 Organisation & 17 Individual applications to be considered.

Individual Applications

- 2 applications were successful for school trips. Total 400.00.
- 8 applications were successful for swimming lessons. Total £1600.00.
- 2 applications were successful for school transport. Total £400.00.
- 1 application was successful for specialist improvements. £1860.00.
- 1 application was successful for the provision of meal vouchers for senior citizens for the next three months. (Mrs Oakley left the room and took no part in voting). Total £5000.00.
- 3 applications were refused as they did not meet the criteria of the charity.

The Howe Trust – Application declined as it is not a Horspath organisation.

Horspath Senior Residents – Awarded £3900.00 for meals and day trips.

St Giles Church – Awarded £300.00 for tree pruning. (Mr Lowe left the room and took no part in voting).

Horspath Magazine – Awarded £2472.00 for 6 editions. (Mr Lowe left the room and took no part in voting).

Horspath Cricket Club – Awarded £500.00 towards a new mower.

Horspath Hub – Awarded £300.00 for the Making Time Creating Craft group.

Horspath Parish Council – Application deferred until 2 Independent Advisors are present.

A total of £16,732.00 was awarded.
