11. AOB.

- Mr Burgess asked for an update on the new email addresses and the review of the grant a. application forms. The Clerk confirmed that Lemoneye are working on these two items but they have not yet been completed. Mr Burgess suggested that Trustees have a gmail email address. Mr Igoe agreed to contact a resident in the village who may be able to assist.
- Mrs Oakley reported on behalf of the Senior Residents Club who currently have around 60 b. members. They receive a grant to cover the cost of day trips for Horspath residents only and outside members have to cover their own cost. The Senior Residents are concerned that the Club may close if members from outside of the village leave the club. Trustees agreed that the grant from HSPC is only for Horspath residents only. Mr Hamlet stated that members from outside of the village are willing to pay for their trips.
- The Clerk informed Trustees that the payment for the new mower was made from HSPC account c. and not HPC account. Trustees agreed that the Clerk transfer the cost of the mower to HPC account so that the VAT can be reclaimed and paid back into the HSPC account.
